

General Meeting--March 22 no it's 21

In attendance--Terrina, Doug, Rosco, Carol, Jane, Mary, Mike R., Bob, Gary, Brenda, Sue, Mike C., Ken, and Steve. (the Doug was Doug E.)

- 1-Terrina reported that she had saved \$2.10 so far.
- 2-Stanley Aronowitz wants to publish a 4 times a year journal of 128 pages, and Carol suggests that we offer a 15% reduction in price so that we have more of a chance of getting the job. It was also stated that he was approaching Red and Black (those anarchists), and that their price could be significantly lower than ours if they liked the work (job). It was decided that we would check with customs about the possibility of shipping the negs across the border for printing, and that we would offer our commercial book prices, and suggest that our demi-tab prices were open to negotiation, on the basis that our book prices were low now.
- 3-Swartz's Marxist Algebra: he wants us to typeset and print, will take care of advertising and distribution, and will pay us when the money comes in. A committee of Mike R., Sue and Ken will study the situation and report by the next meeting.
- 4-Dumont Press-Jerry (the semi-snake(objective minutes)) has a Multi 1850 which he would be willing to part with for the mere price of \$2400-2800. Several people, namely Doug E., Steve and Gary, said that they would be willing to put money into the capital purchase, on a loan basis, if that was what Dumont wanted. Several people, namely Bob, questioned whether that was the direction that Dumont should put its energy. A committee which would study areas of possible expansion and provide the financial information necessary to consider these possibilities more seriously, was struck, consisting of Jane, Gary, Doug E., and Bob.
- 5-The sink was suck, on the premise that we could get a servicable sink for less than \$425.
- 6-Sue was the only one available to go to Eddie and Donna's on Mar 21, and Mar. 28 was suggested as an alternative. with Doug E and Gary interested, as well as Bob and Murray who would go after their course in either case. It was assumed that Bob would notify Eddie or Donna about this turn of events.
- 7-Bfp-UIC someone from BFP wants to go on payroll, at no cost to Dumont, to build up credits for UIC. This proposal was rejected on the basis that it would look bad for us to hire someone in the midst of laying everyone off so they could go on UIC.
- 8-CPC-ML-Most people indicated that they either agreed with the letter to CPC-ML, or had written in their comments. A committee of Doug R and Rosco was struck to re-write the letter to include those comments.
- 9-Future Meetings-Small groups Monday at 3pm, Union Executive Monday at 2pm, camera course the following week, probably on Monday.
- 10-After the meeting had adjourned, we talked about how much a drag the meeting was and decided: that meetings would begin on the dot of 3pm, and anyone not there would not be there (no point would be reviewed) and would be on Mondays. As well, a general

meeting logbook would be instituted so that, when someone put a point on the agenda, they could also write it up in the logbook so that everyone who have prior knowledge of the matters to be dealt with.

another point I forgot--the expansion committee (point 4) was to report to the monthly ~~Sunday~~ supper meeting which was scheduled for April 18.
