In terms of BRG non-com. groups we feel that they should actually become our nc groups for the duration and therefor will deal with them as such. This will involve meeting with the nc groups and discussing products etc. and deciding who will do what and all the other nc garbage. Ken is to handle most of this.
- 6. Bob has been given a three month-half hour programme on CKWR for a labour programme. He is willing to share his 30 minutes with anyone (including Roy St's dog Mittens or their cat Humphrey) mostly because he's afraid of talking that long and also because he feels the dialogues important. There willbe a meeting later this week to plan this.
- 7. We will hold off billing the Federation until after the budget is approved in case we have to do anymore for the group. We will also bill for time spent so there.

(I went to Toronto for the milk) Mike C asked why we were to be held responsible for this when the finished product was vastly different from the quoted copy. Ken then added that quotes should be more meshed with the shop. Once again I lost track of the discussion. We will it seems bill Mike Strong for \$25 and forget the rest we will also make sure that late fee penalities are added to both the Cord and Chevron contracts.
