- these negotiations will take into account repossibility in view of the amount of money put into the company, the amount of work in all facets of the labour (ie producing the products, distribution, advertising etc) and who will decide what and is how much authority each group or person will have
- -OPIRG wants representation on the board of directors of the incorporated co.
- suggested names : Dumont Publishing Group, or DP House, Dumong Publishes X Garbage, etc and the name will be decided on later this week after Brian's thoughts are expounded.
- 3. Overtime: MIke C. wondered why in had been necessary to do the overtime in the recent past, both for the book and for regular production work
- he thought we had set too short deadlines to be met considering the number of people we have working this summer and that it had been a part of the decision to work 3 shifts that we regulate our work accordingly
- a general discussion ensued
- Mike R. suggested that we make better use of our few prod meetings and also that they not be so few and far between for deciding what deadlines we should give to jobs that come in so that we have time to do it in that will not inconvenience the customer
- do jobs that come in on the spur of the moment (ie KK) have do bear done immediately?
- decided to be more careful and to claim the overtime that resulted from last week
- OFY people will be getting 2 shifts per week whenever possible and the rest of us will stay on a 3 day week for kkim the time being (hopefully the summer)
- 4. Xerox: it didn't work very well Friday but with a bit of fiddling, it was going alright on Saturday
- Mike C. volunteered to show people how to work it if they didn't know how or had forgotten and to phone a serviceman to look at it (and provide an operator's manuel)

- 5. Contact People: Reeve Bean contact person needed kakes because Bob is going away and the thing is not yet final
- Mike R. volunteered for this it involves finalizing the contract, setting up docketing procedures, and the whole system that is needed for thum
- Murray will be the contact person for the printing of Jesse's book as he is also doing the KRREK cover
- 6. CKWR: this was a non-commercial job being handled by Bob and Henry Crapo was doing a lot of the work even though Bob was around for most of it
- we could possibly do it throught he shop and charge non-comm rates
- this is to be figured out and Murray will take care of it in the meantime
- Mike C. will try to co-ordinate the UW handbooks and Brenda will fo the people's history book if and when it comes in

- Carl phoned to say that they wanted the 2 front and back pages rerun and they would collalate them into the rest of the paper
- -he was to confirm this with Bob on the weakend but never did so we will not run it without his OK
- his demi programme didn't come in so we cancelled bookings for all his stuff (if there were any) pending himself
- about money-we will wait to see if his cheguw for the last part of his first paper bounces then what, god and carl only know
- 8. Shop closed June 30 and July 1
- BEXXNIK 9. OFY/UIC: there was a question of whether the OFY people should keep back deductions from their salaries as they are being paid at a higher rate that others but are not losing any deductions but will in the spring
- this is also true of the people on UIC
- after much discussion the decision was made to: have a system in the spring whereby everyone would figure out what they should have gotten back from the gov't if they had been a full time Dumont member of the books (payroll that is)
